COUNTY BEGINS ITS ANNUAL BUDGETING PROCESS

Johnson County, Iowa - Each year, the Johnson County Board of Supervisors, coordinating with other County elected officials and department heads, conducts a thorough budgeting process before outlining the County's budget for the upcoming fiscal year. The public is invited to attend any and all meetings.

A preliminary schedule for the Fiscal Year 2015 (July 1, 2014-June 30, 2015) budget meetings, including specific department budget discussions, is listed below. Meeting dates, times, and department discussions are subject to change. All meetings are scheduled to take place in the Board Room on the second floor of the Johnson County Administration Building, 913 South Dubuque Street, Iowa City.

The first meeting is 9:00-11:00 am on Tuesday, November 12. Department-specific meetings wrap up in December, with general budget discussions and decisions occurring in January. A public hearing will be held from 5:30 to 7:00 pm on Tuesday, February 25, 2014. The board will discuss and vote on the budget the following week. County budgets must be filed with the State of Iowa by March 15, 2014.
