COUNTY MEDICAL EXAMINER VACANCY

Johnson County, Iowa — The Johnson County Board of Supervisors announces one vacancy for the **County Medical Examiner**. The vacancy is for a two-year term beginning January 2, 2018 and ending January 1, 2020.

To serve as a county medical examiner, a person shall be licensed in Iowa as a doctor of medicine and surgery, a doctor of osteopathic medicine and surgery, or an osteopathic physician.

Please note that the County Medical Examiner application process is specific to the position.
