



Section 5 of Article II of the Constitution of the State of Iowa is repealed and the following adopted in lieu thereof: DISQUALIFIED PERSONS. SEC. 5. A person adjudged mentally incompetent to vote or a person convicted of any infamous crime shall not be entitled to the privilege of an elector.
